Donna talked with an insulation person, who is meeting with Ron tomorrow. Ron has been working on the heating as needed. Mark will try to meet with Ron to ascertain what is needed.

Keren Falkenstein told Mark that the sound system is working now. A kind anonymous person donated a receiver.

Mark has identified \$50 camera/light motion sensors. The recipient can rotate it, talk through it, and/or set off an alarm. Mark will look for good locations for placement.

Mark will announce this Sunday that the defibrillator is missing and inquire whether anyone has it.

Other Committees

Keren and Kristen will do a Hanukkah presentation during a service, and Dennis and Roberta are on for Chinese New Year.

RFJ suggests a roundtable to brainstorm ideas for increasing membership. Lynn can circulate all the ideas we've generated at the last several roundtables.

Katie S. will go over to Ellen Hill's house to see if there are any materials that RE could use.

Donna excused.
